Dear Charlie:

I am hoping to get over to France by the middle of August. The exact date is somewhat uncertain as I may have to stay here until Congress adjourns and I doubt whether they get through for another ten days or longer. On the whole, we have had a pleasant summer here, although just at the moment we are having a heat wave and would be glad to share a bit of it with you on the other side. I hope that I can join you both somewhere in Europe and I will get in touch with you by phone when I reach Paris if it is before your departure for the Norway trip.

I appreciate your having thought of me in connection with the "Mallard." I have checked with our Logistics Section and they tell me that at the moment we have no need for a plane of this particular type as we seem to be adequately equipped. Hence, I suggest you do not hold up any other plans you may have for disposing of it. I am, nonetheless, very appreciative of this chance you have given us.

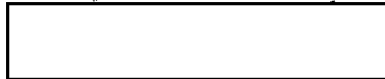
